### Account opening requirements

You must be 16 or over and resident in the Republic of Ireland. You can sign up for a Currency Card in two ways:

- 1 In the post office by completing the form on the reverse and bringing in physical copies of the proof documents set out overleaf.
- 2 On the An Post Money app, which you can download for free from the App Store or on Google Play. You will need to upload copies of the proof documents set out overleaf.

- Household bill
- Bank statement
- Letter from the Revenue/Department of Social Protection

### Free global assistance

# Card Fees

Full list of fees that apply to the An Post Money Currency Card are set out below.

Service	Cost	Explanation
Load/Top-up fee	Free	Fee charged when you top up regardless of payment method. Like a commission fee.

- Euro wallet	1.5%	
Additional card fee	Free	No fee for getting a backup card.
Currency transfer fee	Free	No fee for moving money between wallets. Foreign exchange rate applies, varies each day.
Fee for paying with the card	Free	No fee for paying with your card, whether at retailers or online. Some retailers may charge their own fee.
Fee for cash machine withdrawals	EUR €2.00/US \$2.50 GB £1.50/AU \$3.50 CA \$3.25/ZAR 20.00 TRY 5.50/NZ \$3.50 AED 8.00/CHF 3.00 MXN 40.00/PLN 8.00 CZK 50.00/HRK 15.00 JPY 250.00/SEK 20.00	
Cash out fee at a post office:		Fee for cashing out your card before the card expires, or after a period of 12 months after the expiry date.
- From your foreign currency wallets	Free	
- From your euro wallet	1.5% Maximum €8.00	
Cash out fee by calling card services	€8.00	
Inactivity fee	€2.50 per month	Fee charged after a 15-month period of you not using your card (either by topping up your card, paying for transactions or withdrawing money), including after your card has expired. No fee if you have a zero balance.
Foreign exchange fee	5.75%	Fee for using your card for a transaction in a currency which is not available on your card or you don't have enough balance in the transaction currency and the rest is taken from another currency wallet.
Shortfall fee	€12.50 (or currency equivalent)	Fee charged if a payment takes your balance below zero.
Annual Government stamp duty	up to €5.00 per calendar year	There is a charge of up to €5.00 per calendar year when you use your card for ATM machine withdrawals or at retailers in the Republic of Ireland.
Replacement card fee	Free	Free service to send you a new card whilst you are away if you lose your card or it is stolen or damaged, where this service is available.
